# **Disability Rights Center - NH**

Disability Rights Center – NH, a 501(c)(3) non-profit corporation, was incorporated in 1977 as the Developmental Disabilities Advocacy Center, Inc. to administer the federally created Protection and Advocacy System for people with developmental disabilities in the State of New Hampshire. DRC-NH, which has expanded significantly over the past 45 years, continues to be committed to the following purposes for which it was established:

- To provide legal services and advice to New Hampshire citizens with disabilities who could not otherwise afford such legal services and advice;
- To work with other organizations in recognizing and meeting the needs of individuals with disabilities and their families;
- To develop an awareness among the general public about the needs of individuals with disabilities; and
- To develop awareness among people with disabilities, and their families, about their legal rights.

DRC-NH's mission statement reflects these organizational purposes:

The Disability Rights Center is dedicated to eliminating barriers existing in New Hampshire to the full and equal enjoyment of civil and other legal rights by people with disabilities.

DRC-NH has expanded from a single program to benefit a single disability constituency to currently administering ten federally funded programs that are inclusive of all persons with disabilities, including developmental disabilities, mental illness, physical/orthopedic disabilities and neurological disabilities, including brain injury.

DRC-NH operates in the public interest statewide from its office location in Concord, NH. The authorizing federal legislation requires the organization to pursue and utilize a wide variety of remedies to protect the rights of persons with disabilities including individual representation, class action litigation, investigation of abuse and neglect of people with disabilities, monitoring in facilities serving people with disabilities, education of public officials and training for people with disabilities and their families about their legal rights and how to exercise them.
